

# South Brent School Association 100 Club

## Terms and Conditions

1. The 100 Club has a limit of 100 members at any one time. If more people wish to join, a waiting list will be established. As vacancies occur, new members will be admitted to the club in the order they joined the waiting list.
2. For a cost of £2.50 per number per month, you will be allocated one number between 1 and 100. You can request a lucky number, though if that number is already taken a random number will be allocated.
3. You may apply for more than one number.
4. Numbers enter the draw from the month after the first payment is received.
5. The winning numbers will be drawn on the second Friday of the month using a recognised random number generator. A first, second and third place number will be drawn. Each draw will be recorded, and the video posted to the School Associations Facebook account for public viewing.
6. The prize fund is 35% of the value of the entry money received for that draw, allocated as follows: 20% to the first number drawn, 10% to the second number drawn, 5% to the final number drawn. For example, if 60 numbers are sold, the total money received will be £150, giving a first prize of £30, second prize of £15 and third prize of £7.50.
8. Payments must be made by Standing Order unless otherwise agreed.
9. One month notice is required for cancellation. Prepaid draws will not be refunded, but the member will still be entered for the period that has been prepaid.
10. Members' numbers will only be entered if their subscription is up to date.
11. If a member has no valid reason for missing a payment, their number may be reallocated to someone on the waiting list.
12. If the Standing Order pays for more than one ticket and there is an issue with the full payment, all tickets paid for via that standing order will be invalid.
13. The winners will be contacted by e-mail. The numbers of each month's winners will be published on the SBSA Facebook and website. Names may be published depending on the members preference indicated on the signup form.
14. Winnings will be transferred to the winners' bank accounts. SBSA will contact the winner for the bank account details after their first win and transfer the prize money within 7 days of the details being received. All future winnings will be paid with seven days of the draw.
15. It is the responsibility of the member to ensure that the SBSA is advised of any change of bank details by emailing [hello@southbrentsa.co.uk](mailto:hello@southbrentsa.co.uk)
16. If a winner cannot be contacted, the winnings will be retained by the SBSA after a period of six months.
17. The 100 Club will be run by the SBSA. In case of any dispute the decision of the SBSA Committee is final.

18. Unless otherwise advised, a member will be deemed to have left the 100 Club if his/her subscription renewal remains unpaid for a period of one month.
19. The 100 Club is run as a Small Society Lottery in accordance with the Gambling Act 2005 and is open to anyone over the age of 16.
20. Application for membership will be deemed acceptance of the 100 Club Terms & Conditions.
21. The SBSA Committee may amend the rules of the 100 Club at any time. Members will be informed of changes by letter or email.
